PROVINCIAL APPROPRIATION ORDINANCE NO. 020-2008

**AN ORDINANCE APPROPRIATING THE AMOUNT OF
ONE HUNDRED THOUSAND PESOS (P100,000.00) FROM
THE PAGCOR FUNDS FOR THE PAYMENT OF THE
BLOOD HANDLING FEE TO BE USED BY INDIGENT
PATIENTS.**

**WHEREAS, poverty has contributed to the deaths among indigent
folks who are in need of blood but have no money for the purpose;**

**WHEREAS, a majority of indigent patients who need blood cannot
easily raise the amount needed for the payment of blood handling fee;**

**WHEREAS, the blood handling fee is being used to augment the
cost of examination for malaria, syphilis, HIV and others with the
Philippine National Red Cross (PNRC) officially designated to collect and
release examined blood;**

NOW, THEREFORE, Be it Ordained that

Section 1. There is hereby appropriated the amount of One Hundred Thousand Pesos (P100,000.00) from the PAGCOR funds for the payment of blood handling fee to be used by indigent patients;

Section 2. This Ordinance shall take effect immediately upon approval.
